I recognize my responsibility to ensure that said minor child participates only in those activities for which he/she has the required skills, qualifications, training and physical conditioning. I understand that the Diamond "C" Bow Hunting Ranch shall have no responsibility to pay for medical treatment and related costs if said minor child is injured.

I understand and acknowledge that I have read and reviewed the Diamond "C" Bow Hunting Lease Agreement and Rules & Regulation forms with my child.

Knowing the risks described above, I agree, personally and on behalf of the minor child named above, to assume all the risks and responsibilities surrounding my minor child's participation in hunting and recreational activities at the Diamond "C" Bow Hunting Ranch. To the fullest extent allowed by law, I hold harmless and agree to indemnify the Diamond "C" Bow Hunting Ranch, its owners, staff, employees and agents, from and against any present or future claim, cause of action, loss or liability for injury to person or property, which said minor child may suffer or for which said minor child may be liable to any other person, related to said minor child's participation in recreational activities at the Diamond "C" Bow Hunting Ranch and use of the hunting equipment, resulting from any cause whatsoever, and regardless of fault.

I am at least eighteen years of age and have carefully read and freely signed this Liability Waiver and Release Form (Minor Child). I understand and agree that no oral or written representations can or will alter the contents of this document. I agree that this agreement shall be governed by the laws of the State of Texas (excluding its conflict of laws principles).
